The thought of hiring a personal injury attorney is not something most people want to entertain. However, if you find yourself injured in an accident, regardless of the circumstances, you may want to consult with a legal professional for advice on whether you have the right to receive compensation.



Regardless of where you live, you will have the opportunity to speak with multiple personal injury attorneys.

That being said, there will come a time when you have to hire one law firm to represent you.

How you make the decision as to which attorney to hire depends on numerous factors. To make this easier, you should ask the following five questions:

1. What is my case worth?

While this can be a difficult question for any personal injury attorney to answer, you should push for some idea. This will give you a better idea of what to expect as you move forward.

Note: even if an attorney cannot give you an exact number, they should be able to provide basics on what will determine how much you receive.

2. What is your contingency fee?

It would be nice if you could hire a personal injury attorney for free, but this is not the way the industry works. Known as a contingency fee, this is what your attorney is paid if they win your case.

The lower the fee the less money you will pay out of any settlement you receive. Generally speaking, this fee averages 33 percent.

3. Am I responsible for any expenses?

This is an important question, as you want to know if you are going to pay any money out of pocket as your case moves forward. Known as advanced case costs, these can quickly add up.

4. How much experience do you have with cases that are similar to mine?

If you don't ask this question, there is no way of knowing that you are getting the right attorney on your side. You only want to consider legal professionals who have many years of personal injury experience, ensuring that they have the knowledge to win your case.

Note: you can ask this question directly, but don't overlook the fact that you can dig up plenty of related information online.

5. Do you have enough time in your schedule to take on my case?

Even if you find a great personal injury attorney, if the person does not have time for your case you should consider another option.

As unfortunate as it may be, some attorneys will take on your case, just to pass it along to somebody else at the firm.

Tip: to protect against this, make sure you know who is staffed with the responsibility of working your case.

BE OPEN TO ASKING QUESTIONS
